Product-Specific and state CE Annuity Suitability Training Requirements:

What Training is required?

If you are in an NAIC State, 2 Training courses need to be completed:

- 1) Athene (AVIVA) Product-Specific Training, and
- 2) Your state 4-Hour CE Annuity Suitability Model Law Training

If you are not in an NAIC State:

Athene (AVIVA) Product-Specific Training is required

Where can I complete the ATHENE (AVIVA) Product training?

The Athene (AVIVA) Product Training is only available on the RegEd Training website. Make sure you are using **Internet Explorer**.

PLEASE READ: The RegEd Training Platform and Reged.com do NOT use the same username and password.

Returning Agents: In the upper right-hand corner **LOG IN BOX**, enter your **RegEd Training Platform** Username and Password and click **GO**.

First Time Agents need to Register. In the upper right-hand corner **LOG IN BOX**, click **SIGN UP**. Fill out the Registration information.

After you log on or Register: Go to the Producer Status Page.

Select **ENTER PRODUCT CODE** in the menu on the Left.

If you have completed all but the Athene/AVIVA Benefit 10 product training, please **complete this course:**

ATH Benefit 10 (IA) and Enhanced Benefit Rider, course # 14ATHENE_04

Enter Product Code: **B10_2014**

Enter Product Code for the required course and click **Submit**.

Click on **GO TO REQUIREMENT** It will take a minute for the course to load. **COMPLETE THE COURSE.**

At the end of the course: Be sure to click **ATTEST** when finished. Click on the **A** beside **TRUE**. Answer 8 course evaluation questions. Click **Submit**. **Print your completion certificate(s) and forward to cathym@cencoinsurance.com, or fax to 916-920-8734.**
